**I. STATEMENT**

1. On December 20, 2024, Petitioner Bull Dog Recovery (“Petitioner”) filed a Petition to reverse an initial determination of driver disqualification pursuant to § 40-10.1-401(2)(b), C.R.S.

2. On January 8, 2025, the matter was referred to an Administrative Law Judge (“ALJ”) for disposition by minute entry during the Commission's Weekly Meeting.

3. On January 8, Trial Staff of the Public Utility Commission (“Trial Staff”) filed its Notice of Intervention as of Right, Entry of Appearance and Notice Pursuant to rule 1007(a) and Rule 1401, and Request for Hearing

**II. STATUS OF PENDING CASES**

4. In examining the filings made in the above captioned proceeding it appears that there were at least two open court cases in Adams County when the denial letter was issued in October of 2024. The resolution of those cases, and any other open court cases, could have an effect on any decision made in the above captioned proceeding.

5. To prevent those cases having an effect shortly before or after a hearing is held in this proceeding, the ALJ shall order the parties to file an update on the status of the two court cases listed at the top of page four of the denial letter. The parties shall also state if there are any additional court cases pending against Mr. Fernandez in Colorado or any other state.

6. The Parties have until March 7, 2025, to make this filing. This filing should be made as a confidential filing if necessary.

7. If Trial Staff does not have any further information about the two cases listed at the top of page four of the denial letter or no information of additional cases since the issuance of the denial letter, any filing should state that fact.

8. Failure of the Petitioner to make a filing with the updated status of the two cases listed on page four of the denial letter may lead to a dismissal of the petition. Failure to list any additional cases pending, may also be grounds for dismissal of the petition.

### **III. ORDER**

#### **It is Ordered That:**

1. The Parties are ordered to file a status update on the open cases listed at the top of page four of the denial letter by March 7, 2025. This filing shall also list any new case involving the Petitioner and the status of these new cases. If necessary, these filings should be filed confidentially.

2. Failure to make the required filings may lead to a dismissal of the petition.

3. Failure to include any new cases with their status, may lead to a dismissal of the petition.

4. A decision will issue after March 7, 2025, detailing how this matter shall proceed.

5. The Parties shall be held to the advisements in this Decision.

6. This Decision is effective immediately.
