I. <u>BY THE COMMISSION:</u>

Statement, Findings and Conclusions

- 1. On November 19, 2002, Doug Scott, doing business as City and Sites, filed an application for approval to transfer Certificate of Public Convenience and Necessity (CPCN) PUC No. 55702 to Estes Park Express, Ltd.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on December 2, 2002. The Commission set this matter for hearing on February 11, 2003.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. The information submitted in support of this application warrants the grant of the requested transfer.

- 5. The financial standing of Estes Park Express, Ltd., has been satisfactorily established.
- 6. Estes Park Express, Ltd., is ready, willing, and able to properly perform the service as requested.
- 7. This application for permanent approval of the transfer of CPCN PUC No. 55702 is in the public interest.

II. ORDER

A. The Commission Orders That:

- 1. The hearing set for February 11, 2003, is vacated.
- 2. This application was deemed complete on January 10, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Doug Scott, doing business as City and Sites, for approval to transfer Certificate of Public Convenience and Necessity PUC No. 55702, subject to encumbrances, if any, against the authority, to Estes Park Express, Ltd., is granted.
- 4. Estes Park Express, Ltd., shall operate in accordance with all applicable Commission rules and regulations.
- 5. Approval of the transfer of Certificate of Public Convenience and Necessity PUC No. 55702 is conditioned on the prior filing by Doug Scott, doing business as City and Sites, of delinquent reports, if any, covering operations under the certificate up to the consummation of the transfer.

- 6. Estes Park Express, Ltd., shall adopt the tariff of Doug Scott, doing business as City and Sites, which shall become that of Estes Park Express, Ltd., until changed in accordance with the Public Utilities Law. Doug Scott, doing business as City and Sites, shall file a terminating annual report from the first of January, 2002, to the date of this Order. An acceptance of transfer signed by both Doug Scott, doing business as City and Sites, and Estes Park Express, Ltd., shall be filed with the Commission. Estes Park Express, Ltd., may not begin operations until it has received notice in writing from the Commission that it is in compliance and may begin service.
- 7. If Doug Scott, doing business as City and Sites, and Estes Park Express, Ltd., do not comply with the requirements of this Order within 60 days of its effective date, then the approval to transfer Certificate of Public Convenience and Necessity PUC No. 55702 shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.
 - 8. This Order is effective immediately on its Mailed Date.
