I. <u>BY THE COMMISSION:</u>

Statement, Findings and Conclusions

1. On November 18, 2002, Sonrisas, Inc., doing business as CC Transport

(Sonrisas), filed an application for permanent authority to conduct operations as a common

carrier by motor vehicle for hire for the transportation of passengers and their baggage, in call-

and-demand limousine service, between all points in the Counties of Adams, Arapahoe, Denver,

Douglas, and Jefferson, State of Colorado, on the one hand, and the following Colorado

Department of Corrections facilities in the East Canon Complex near Canon City, Colorado: (1)

Arrowhead Correctional Center; (2) Centennial Correctional Facility; (3) Colorado State

Penitentiary; (4) Four Mile Correctional Facility; (5) Fremont Correctional Facility; and (6)

Skyline Correctional Center, on the other hand.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on December 2, 2002. The Commission set this

matter for hearing on February 10, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

- 4. The information submitted in support of this application warrants the grant of the requested authority.
- 5. The present or future public convenience and necessity requires, or will require, the transportation service as requested.
 - 6. Sonrisas is ready, willing, and able to properly perform the service as requested.
 - 7. This application for permanent authority is in the public interest.

II. ORDER

A. The Commission Orders That:

- 1. The hearing set for February 10, 2003, is vacated.
- 2. This application was deemed complete on January 9, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. Sonrisas, Inc., doing business as CC Transport, is granted a Certificate of Public Convenience and Necessity to operate as a common carrier by motor vehicle for hire with authority as set forth in the Appendix. This Order grants a CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY.
- 4. Sonrisas, Inc., doing business as CC Transport, shall operate in accordance with all applicable Commission rules and regulations.

5. Sonrisas, Inc., doing business as CC Transport, shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Sonrisas, Inc., doing business as CC Transport, may not begin operations until these requirements have been met and notice in writing has been received from the Commission stating it is in compliance and may begin service.

- 6. If Sonrisas, Inc., doing business as CC Transport, does not comply with the requirements of this Order within 60 days of its effective date, then the authority to conduct operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.
 - 7. This Order is effective immediately on its Mailed Date.
