# I. <u>BY THE COMMISSION:</u>

#### A. Statement

- 1. On December 4, 2002, 4 Inverness Court East Office Condominium Association, Inc., filed an application for exemption from rate regulation as an electric master meter operator under § 40-1-103.5, C.R.S.
- 2. The Commission issued the notice of application filed on December 6, 2002. No request for intervention or opposition to this application has been filed. The Commission has reviewed the application and will deem it complete. The Commission will, therefore, decide this matter without hearing pursuant to § 40-6-109(5), C.R.S.
- 3. Upon review of the application, the Commission finds that 4 Inverness Court East Office Condominium Association, Inc., will be providing electric service through a master meter in compliance with the provisions of § 40-1-103.5, C.R.S. Applicant 4 Inverness Court East Office Condominium Association, Inc., will be receiving electric service from Public Service Company of Colorado and in turn will provide a like service to the three

office units of 4 Inverness Court East Office Condominium Association, Inc., 4 Inverness Court East, Englewood, Colorado 80112.

- 4. Applicant 4 Inverness Court East Office Condominium Association, Inc., agreed that if granted this application of exemption from rate regulation as a master meter operator, it would comply with all applicable requirements of Rule 33 of the Rules Regulating the Service of Electric Utilities, 4 *Code of Colorado Regulations* 723-3.
- 5. The Commission finds that the application for exemption from rate regulation as an electric master meter operator under public utility law is in the public interest and should be granted.

# II. ORDER


## **A.** The Commission Orders That:
