I. **BY THE COMMISSION:** 

> **Statement** A.

On January 21, 2003, Estes Park Express, LTD (Estes Park Express), filed an 1.

application for authority to publish Revised Page 12A to Passenger Tariff Number 1 to become

effective on less-than-statutory notice. Estes Park Express provides scheduled service between

Estes Park and Denver International Airport, serving intermediate points including Denver.

2. Estes Park Express proposes two rate reductions in Revised Page 12A of

Passenger Tariff No. 1. First, with every party, the first adult passenger will pay full fare and the

second will ride free. Second, any adult accompanied by up to two children, 18 years of age or

younger, will pay full fare and the children will ride free. The proposal will result in fare

reductions of up to fifty percent. The proposal will expire on April 30, 2003.

3. In support of the application, Estes Park Express states that rider-ship is at less

than ten percent of capacity in this off-season period. Further, since the vans are required to

operate scheduled service whether or not they have riders, no additional costs are contemplated.

4. Rule 31(f)(1) of the Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1, allows an order authorizing carriers to change tariffs or time schedules on less-than-statutory notice for good cause shown.

5. The Commission finds that good cause has been shown for the approval of the proposed changes in Revised Page No. 12A of Passenger Tariff No. 1 and that the application should be granted.

## II. ORDER

## **A.** The Commission Orders That:

- 1. The application of Estes Park Express, LTD, to publish Revised Page 12A to Passenger Tariff No. 1 on less-than-statutory notice is granted.
- 2. Revised Page 12A to Passenger Tariff No. 1, shall be published on not less than one day's notice to the Commission and the general public.
  - 3. This Order is effective on its Mailed Date.
