THE APPLICATION OF RAMBLIN' EXPRESS, INC., DOING BUSINESS AS ROCKY MOUNTAIN LIMOUSINE, INC., FOR AUTHORITY TO SUSPEND OPERATIONS UNDER A PORTION OF CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY PUC NO. L275.

**COMMISSION ORDER GRANTING
PARTIAL SUSPENSION OF OPERATIONS**

I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

1. On December 19, 2002, Ramblin' Express, Inc., doing business as Rocky Mountain Limousine, Inc., filed an application seeking authority to suspend operations under the portion of Certificate of Public Convenience and Necessity (CPCN) PUC No. L275 authorizing the transportation of passengers and their baggage in scheduled service between the Broadmoor Hotel, 10 Lake Circle, Colorado Springs, Colorado, 80906, on the one hand, and points within Colorado Springs, Colorado, on the other hand, from January 20, 2003, through July 20, 2003.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on December 30, 2002. The Commission set this matter for hearing on March 11, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants the grant of the requested partial suspension.

5. The application for authority to suspend operations under a portion of CPCN PUC No. L275 is in the public interest.

II. ORDER

A. The Commission Orders That:

1. The hearing set for March 11, 2003, is vacated.

2. This application was deemed complete on February 3, 2003, within the meaning of § 40-6-109.5, C.R.S., and 4 Code of Colorado Regulations 723-1-71 (a).

3. The application filed by Ramblin' Express, Inc., doing business as Rocky Mountain Limousine, Inc., for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. L275 is granted as to the following portion: Item III. Transportation of passengers and their baggage in scheduled service between the Broadmoor Hotel, 10 Lake Circle, Colorado Springs, Colorado, 80906, on the one hand, and points within Colorado Springs, Colorado, on the other hand.

4. The suspension of motor vehicle operations under the above-described portion of Certificate of Public Convenience and Necessity PUC No. L275 is authorized from January 20, 2003 through July 20, 2003.

5. On or before June 20, 2003, Ramblin' Express, Inc., doing business as Rocky Mountain Limousine, Inc., shall file a written request either to reinstate the suspended portion of Certificate of Public Convenience and Necessity PUC No. L275 or to extend the suspension period.

6. Prior to reinstatement, Ramblin' Express, Inc., doing business as Rocky Mountain Limousine, Inc., shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Ramblin' Express, Inc., doing business as Rocky Mountain Limousine, Inc., shall also file a proper tariff and pay the appropriate vehicle identification fee.

7. The failure to file a written request either to reinstate the suspended portion of Certificate of Public Convenience and Necessity PUC No. L275 or to extend the suspension period on or before June 20, 2003, may result in revocation of the suspended portion of the certificate without further notice.

8. This Order is effective immediately on its Mailed Date.

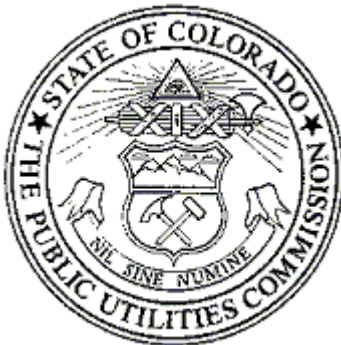
