Rule 25 states that the annual report shall be submitted on forms prescribed by the Commission, and requires that regulated utilities file any additional reports specified by the

2. This order specifies the forms to be filed by telecommunications utilities for the 2002 reporting year. These utilities shall submit the annual report in accordance with the requirements listed on Appendix A to this Order.

3. All telecommunications utilities must also submit a copy of the report of gross regulated intrastate operating revenues required by the Colorado Department of Revenue, Form DR 525. That form may be found on the Commission's website at <a href="https://www.dora.state.co.us/puc">www.dora.state.co.us/puc</a>.

## B. Conclusion

- 4. The Commission finds that each utility holding a certificate of public convenience and necessity or letter of registration to provide telecommunications services, or are registered to provide resold toll services, in accordance with Title 40 of the Colorado Revised Statutes during calendar year 2002, shall file an annual report in the form prescribed here. Such reports shall be filed no later than April 30, 2003, in compliance with Rule 25 of the Commission's Rules of Practice and Procedure.
- 5. Each filing utility is required to identify the individual authorized to file on its behalf and designated as the Annual Report Contact. If no specific designation was made to the Commission, an officer of the utility will be considered as the Annual Report Contact for the purpose of this filing requirement. The Commission notes that, in accordance with § 40-7-106, C.R.S., every officer, agent, or employee of any public utility who violates or fails to comply with or who aids or abets any violation by any public utility of, among other things, any order, decision, or rule of this Commission, commits a class 2 misdemeanor and may be punished as provided in § 18-1.3-501, C.R.S.
- 6. A utility subject to this Order may file a motion for extension of time to file its annual report, which may be granted for a period not to exceed 30 days, if good cause is shown why it is unable to comply with the April 30, 2003, deadline. Such a motion for extension of time may not include submittal of the Form DR 525.

## II. ORDER

## **A.** The Commission Orders That:

- 1. On or before April 30, 2003, each utility holding a certificate of public convenience and necessity or a letter of registration to provide telecommunications services, or are registered to resell toll services, in Colorado during calendar year 2002 shall file an annual report in the form prescribed in the order, and any additional reports as required by Appendix A to this Order.
- 2. Utilities must also submit a copy of the Colorado Department of Revenue Form DR 525 no later than April 30, 2003. Entities may not request an extension of time to file that report.
