**I. BY THE COMMISSION:**

**A. Statement, Findings and Conclusions**

1. On December 24, 2002, Marianne R. Doehling, doing business as Diamond Cab, filed an application seeking authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 53260.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on December 30, 2002. The Commission set this matter for hearing on March 10, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with the application warrants the grant of the requested suspension.

5. The application for authority to suspend CPCN PUC No. 53260 is in the public interest.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The hearing set for March 10, 2003, is vacated.
2. This application was deemed complete on February 5, 2003, within the meaning of § 40-6-109.5, C.R.S.
3. The application filed by Marianne R. Doehling, doing business as Diamond Cab, for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 53260 is granted.
4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 53260 is authorized from December 24, 2002 through June 24, 2003.
5. On or before June 24, 2003, Marianne R. Doehling, doing business as Diamond Cab, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Marianne R. Doehling, doing business as Diamond Cab, shall also pay the appropriate vehicle identification fee. If the suspension period is to extend beyond June 24, 2003, Marianne R. Doehling, doing business as Diamond Cab, shall file a written request by May 23, 2003, to extend the suspension period.
6. The failure to timely file the proper insurance may result in the revocation of the certificate without further notice.

7. This Order is effective immediately on its Mailed Date.
