NINTH REVISED STATEMENT OF GENERALLY  
AVAILABLE TERMS AND CONDITIONS**

**I. BY THE COMMISSION**

**A. Statement**

1. On March 4, 2003, Qwest Corporation (Qwest) filed its Ninth Revised Statement of Generally Available Terms and Conditions (SGAT), and its Notice of Filing Ninth Revised Statement of Generally Available Terms and Conditions and Motion for Approval (Notice and Motion). In those submittals, Qwest requests that we approve its Ninth Revised SGAT.

2. In order to assure adequate notice of the filings to potentially interested persons, we direct Qwest to do the following: Within seven days of the effective date of this order Qwest shall send by email a copy its Notice and Motion to each person or company having an effective or proposed interconnection agreement with Qwest.<sup>1</sup> That electronic notification shall advise those persons or companies that: (1) Qwest, through the attached Notice and Motion, has requested Commission approval of its Ninth Revised SGAT; (2) a copy of the proposed Ninth

Revised SGAT is available for review on Qwest's website in redline format;<sup>2</sup> and (3) interested persons may file with the Commission,<sup>3</sup> in this docket, comments, objections, or requests for hearing relating to the Ninth Revised SGAT within 21 days of the date of Qwest's electronic notification.

## **II. ORDER**

### **A. The Commission Orders That:**

1. Qwest Corporation shall, within seven days of the effective date of this Order and before sending the electronic notification required by this Order, post on its website a copy of its Ninth Revised Statement of Generally Available Terms and Conditions in redline format.
2. Within seven days of the effective date of this Order, Qwest Corporation shall provide electronic notification of its Notice of Filing Ninth Revised Statement of Generally Available Terms and Motion for Approval, consistent with the above discussion.
3. This Order is effective on its Mailed Date.
