**COMMISSION ORDER GRANTING
EXTENSION TO CONTRACT CARRIER PERMIT**

I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

1. On January 29, 2003, Mobility Transportation & Services, Inc. filed an application for permanent authority to extend operations under Contract Carrier Permit No. B-9798 to include (1) the transportation of passengers and their baggage between the facilities of Craig Rehabilitation Hospital, at or near 3425 South Clarkson Street, Englewood, Colorado, on the one hand, and, all points in the State of Colorado, on the other hand; and (2) to eliminate Denver Options, Inc., as a customer. This application is restricted as follows: (A) To providing transportation service for only Craig Rehabilitation Hospital, at or near 3425 South Clarkson Street, Englewood, Colorado; and (2) To providing transportation service in wheelchair accessible vans.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on February 10, 2003. The Commission set this matter for hearing on April 14, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with the application warrants the grant of the requested authority.

5. A present and special need for the requested transportation services exists. A grant of the requested authority will not impair the efficient public service of any authorized common carrier providing a similar service.

II. ORDER

A. The Commission Orders That:

1. The hearing set for April 14, 2003, is vacated.
2. This application was deemed complete on March 12, 2003, within the meaning of § 40-6-109.5, C.R.S.
3. Mobility Transportation & Services, Inc., is authorized to extend operations under Contract Carrier Permit No. B-9798 as requested in this application.
4. The complete authority under Contract Carrier Permit No. B-9798, as extended, shall be as set forth in the Appendix and this Order is a PERMIT.
5. Mobility Transportation & Services, Inc. as the holder of Contract Carrier Permit No. B-9798, shall operate in accordance with all applicable Commission rules and regulations.

6. Mobility Transportation & Services, Inc. shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Mobility Transportation & Services, Inc. may not begin extended operations until these requirements have been met and notice in writing has been received from the Commission stating it is compliance and may begin service.

7. If Mobility Transportation & Services, Inc. does not comply with the requirements of this Order within 60 days of its effective date, then the authority to extend operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.

8. This Order is effective immediately on its Mailed Date.
