I. **BY THE COMMISSION** 

> Α. Statement

1. By Ordering Paragraph No. 1 in Decision No. C02-923, the effective date of the

tariff sheets filed by Greeley Gas Company now known as Atmos Energy Corporation (Atmos)

on June 21, 2002 under its Advice Letter No. 432 was suspended for 120 days, until

December 30, 2002, or until further order of the Commission.

2. On October 16, 2002, the Commission adopted Decision No. C02-1168 modifying

the suspension period in this docket as a result of the filing of Advice Letter No. 432-Amended

by Atmos on October 4, 2002, which changed the effective date of the tariffs under suspension in

this docket to allow additional time for the investigation of the issues involved in this docket.

3. On December 18, 2002, the Commission adopted Decision No. C02-1436

modifying the suspension period in this docket due to the filing of Advice Letter No. 432-Second

Amended for the purpose of once again postponing the effective date of the tariffs under

suspension in this docket to allow more time for the investigation of the issues involved.

Decision No. C03-0334 DOCKET NO. 02S-442G

Decision No. C02-1436 suspended the effective date of the tariffs filed by Atmos under Advice Letter No. 432, as modified by Advice Letter No. 432-Amended and Advice Letter No. 432-Second Amended, for 120 days until April 11, 2003, or until further order of the Commission.

## **B.** Findings of Fact

4. The Commission finds that its consideration of this matter will not be completed before April 11, 2003, and it is therefore necessary to suspend the effective date of these tariffs for an additional 90 days, or until further order of the Commission.

## II. ORDER

## **A.** The Commission Orders That:

- 1. The effective date of the tariff sheets filed by Atmos Energy Corporation, formerly known as Greeley Gas Company, on June 21, 2002, under its Advice Letter No. 432, as modified by Advice Letter No. 432-Amended, filed October 4, 2002, and Advice Letter No. 432-Second Amended, filed December 5, 2002, is further suspended for 90 days until July 10, 2003, or until further order of the Commission.
