I. **BY THE COMMISSION:** 

> Α. Statement, Findings and Conclusions

On March 10, 2003, Thomas J. Salisbury, doing business as Sandbox Buses, filed 1.

an application for permanent authority to conduct operations as a contract carrier by motor

vehicle for hire for the transportation of passengers and their baggage, between all points in

Prowers County, State of Colorado, on the one hand, and all points in the Counties of Baca, Bent,

and Kiowa, State of Colorado, on the other hand. This application is restricted to providing

transportation services for only Outwest Farms, 207 East Oak Street, Lamar, Colorado 81052.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on March 24, 2003. The Commission set this

matter for hearing on May 22, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

4. The information submitted with the application warrants the grant of the requested authority.

5. A present and special need for the requested transportation service exists. A grant of the requested authority will not impair the efficient public service of any authorized common carrier providing a similar service.

## II. ORDER

### **A.** The Commission Orders That:

- 1. The hearing set for May 22, 2003, is vacated.
- 2. This application was deemed complete on April 25, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. Thomas J. Salisbury, doing business as Sandbox Buses, is granted authority to operate as a Class B contract carrier by motor vehicle for hire with authority as set forth in the Appendix. This Order is a PERMIT.
- 4. Thomas J. Salisbury, doing business as Sandbox Buses, shall operate in accordance with all applicable Commission rules and regulations.
- 5. Thomas J. Salisbury, doing business as Sandbox Buses, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Thomas J. Salisbury, doing business as Sandbox Buses, shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Thomas J. Salisbury, doing business as Sandbox Buses may not begin operations until these requirements have been met and written notice has been received from the Commission stating it is in compliance and may begin service.

6. If Thomas J. Salisbury, doing business as Sandbox Buses, does not comply with the requirements of this Order within 60 days of its effective date, then the authority to conduct operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.

- 7. This Order is effective immediately on its Mailed Date.
