I. <u>BY THE COMMISSION</u>

A. Statement and Findings of Fact

1. On March 20, 2003, DMJ Communications (Colorado), Inc. (DMJ), and

USURF Communications, Inc. (USURF), filed a joint application to execute a transfer. 4 Code

of Colorado Regulations 723-25-8.

2. On April 11, 2003, DMJ and USURF by and through their attorneys Kissinger &

Fellman, P.C., filed a notice of withdrawal of the application.

3. Applicants DMJ and USURF have represented to Staff of the Commission, in a

meeting held on April 11, 2003 regarding another matter, that the grounds for withdrawal relate

to the fact that the application was filed for entities that are not within the jurisdiction of the

Commission.

4. On April 24, 2003, the law firm of Kissinger & Fellman, P.C., counsel for DMJ

and USURF filed a Motion to Withdraw as Counsel. In the motion, counsel indicates that one of

the entities it represents no longer wishes counsel to represent it in this matter, and the other

entity¹ has not communicated its intentions to counsel after multiple requests. Consequently, counsel requests that it be allowed to withdraw as counsel of record for DMJ and USURF.

5. On April 25, 2003, the law firm of Gorsuch Kirgis LLP entered its appearance on behalf of DMJ for the limited purposes of providing notice of the withdrawal of the Application for Transfer and to request dismissal of the Docket.

II. ORDER

A. The Commission Orders That:


