## I. BY THE COMMISSION

#### A. Statement

- 1. This matter comes before the entire Commission at a Pre-hearing Conference held on April 30, 2003 at the Colorado Public Utilities Commission, Hearing Room A. This matter was set for hearing by Decision No. C03-0329 to determine the merits of an application filed by Alticomm, Inc. (Alticomm), for a certificate of public convenience and necessity (CPCN) to provide local exchange telecommunications services in Colorado. We further set this matter for hearing to address the issues raised by Alticomm's application for rehearing, reargument, or reconsideration filed on March 17, 2003. Commission Staff intervened in the application.

4.) Any objections to discovery requests shall be made at the time of the party's response to the discovery request.

5.) The hearing on this matte shall be held on June 19, 2003 at 9:00 a.m., at which time, the issues to be addressed will be the merits of Alticomm's CPCN application, the issues raised by Alticomm's application for Rehearing, Reargument, or Reconsideration, and any other issues raised by Alticomm's CPCN application.
