I. <u>BY THE COMMISSION:</u>

A. Statement

1. On April 25, 2003, Casino Coach, Inc., filed an application for authority to publish Time Schedule No. 15 to become effective on less-than-statutory notice. Casino Coach, Inc., provides scheduled service between the Boulder, Brighton, Louisville, Longmont and Black

Hawk-Central City.

2. Casino Coach, Inc., proposes to cancel all extant schedules and replace them with one consolidated Schedule No. 15. Casino Coach, Inc., has posted the change in office and pick-up points of the carrier's extant schedules.

3. In support of the application, Casino Coach, Inc., states that it is presently losing

substantial sums under the present schedules and it needs to modify the schedules.

4. Analysis of Time Schedule No. 15 indicates that no addresses of terminal points

in Boulder, Brighton, Louisville, Longmont were published in the proposed schedule as required

by the Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1. Further, Time Schedule No. 15 does not formally cancel all the extant time schedules, without which there would exist duplicative and conflicting time schedules.

- 5. Rule 31(f)(1) of the Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1, allows an order authorizing carriers to change tariffs or time schedules on less-than-statutory notice for good cause shown.
- 6. The Commission finds that good cause has been shown for the approval of the proposed changes in Time Schedule No. 15. Granting of the application is, however, contingent on the filing of such schedule that conforms to Appendix A, Section 12(f), of the Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1.

## II. ORDER

## A. The Commission Orders That:

- 1. The application of Casino Coach, Inc., to publish Time Schedule No. 15 on less-than-statutory notice is granted, on the condition that Time Schedule No. 15 shall be published to conform with Appendix A, Section 12(f), of the Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1, on not less than one day's notice.
  - 2. This Order is effective on its Mailed Date.
