I. BY THE COMMISSION:

Statement

1 This matter comes before the Colorado Public Utilities Commission

(Commission) for consideration of a request for an extension of time to comply with

Administrative Law Judge (ALJ) Decision No. R03-0131 filed by Michael M. Davis, I, dba Stars

and Stripes Transportation (Stars and Stripes).

2. The letter filed by Stars and Stripes requests an extension of time within which to

comply with the ALJ's decision, R03-0313, granting it authority to operate as a contract carrier

by motor vehicle for hire to transport passengers and their baggage between the points specified

in the order.

3. The Order, effective on February 23, 2003, required that Stars and Stripes file

with the Commission, certificates of insurance and appropriate tariffs and pay the issuance fee

and annual vehicle identification fees within 60 days of the effective date of the order.

Therefore, Stars and Stripes had until April 24, 2003, to comply with the requirements of

Decision No. C03-0478 DOCKET NO. 02A-602BP

Decision No. R03-0131. The order further stated that if Stars and Stripes failed to comply with these requirements, the authority granted would be void. However, on good cause shown, the Commission may grant additional time for compliance provided the request is filed with the Commission within the 60-day period.

- 4. Stars and Stripes did not meet the filing requirements of Decision No. R03-0131 within the 60-day period. Stars Stripes did file its request for an extension of time to meet these requirements within the 60-day period.
- 5. The letter filed by Stars and Stripes Transportation was received by the Commission on April 23, 2003. Therefore, the letter was received within the 60-day period stated in Decision No. R03-0313. In his letter Mr. Davis states "My searching for the type [sic] commercial insurance needed for approval have been unsuccessful thus far. I'm hoping to find an insurance broker or company that will assist me in securing a porper insurance certificate. I'm currently in contact with a company called TIB out of California. I hope to hear from them in the next two weeks."
- 6. The Commission finds that good cause exists to grant an extension of time to comply with the requirements of Decision No. R03-0131 for an additional 60 days from the effective date of this order.

A. The Commission Orders That:

- 1. Michael M. Davis, I, dba Stars and Stripes Transportation is granted an extension of time of 60 days from the effective date of this order within which to comply with Decision No. R03-0313.
