I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On April 7, 2003, Rainbows, Inc., doing business as 453-TAXI, filed an

application for permanent authority to extend operations under Certificate of Public Convenience

and Necessity PUC No. 54842 by adding certain seasonal restrictions. The entire revised

authority would read as follows: Transportation of passengers and their baggage, in taxi service,

between all points in the County of Summit, State of Colorado. This certificate is restricted to

providing transportation services: (1) From October 31 through March 31 of the following year;

and (2) From June 30 through August 31 of the same year.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on April 21, 2003. The Commission set this

matter for hearing on June 24, 2003.

- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. The information submitted in support of this application warrants the grant of the requested seasonal restrictions.
 - 5. 453-TAXI is ready, willing, and able to properly perform the service as requested.

II. ORDER

A. The Commission Orders That:

- 1. The hearing set for June 24, 2003, is vacated.
- 2. This application was deemed complete on May 27, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. Rainbows, Inc., doing business as 453-TAXI, is authorized to extend operations under Certificate of Public Convenience and Necessity PUC No. 54842 as requested in this application.
- 4. The complete authority under Certificate of Public Convenience and Necessity PUC No. 54842, as extended, shall be as set forth in the Appendix.
- 5. Rainbows, Inc., doing business as 453-TAXI, shall file a proper tariff, and pay the issuance fee and the appropriate annual vehicle identification fee. Rainbows, Inc., doing business as 453-TAXI, may not begin the extended operations until these requirements have been met and written notice has been received from the Commission stating it is compliance and may begin service.
