**I. BY THE COMMISSION:**

**A. Statement, Findings and Conclusions**

1. On April 16, 2003, Anlance Protection, Ltd., filed an application seeking authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55678 and Contract Carrier Permit No. B-9813.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on April 21, 2003. The Commission set this matter for hearing on June 30, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is non-contested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with the application warrants the grant of the requested suspension.

5. The application for authority to suspend CPCN PUC No. 55678 and Contract Carrier Permit No. B-9813 is in the public interest.

**II. ORDER**

**A. The Commission Orders That:**

1. The hearing set for June 30, 2003, is vacated.
2. This application was deemed complete on May 27, 2003, within the meaning of § 40-6-109.5, C.R.S.
3. The application filed by Anlance Protection, Ltd. for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55678 and Contract Carrier Permit No. B-9813 is granted.
4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55678 and Contract Carrier Permit No. B-9813 is authorized from April 18, 2003 through October 18, 2003.
5. On or before September 18, 2003, Anlance Protection, Ltd. shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55678 and Contract Carrier Permit No. B-9813 or to extend the suspension period.
6. Prior to reinstatement, Anlance Protection, Ltd. shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Anlance Protection, Ltd. shall also file a proper tariff and pay the appropriate vehicle identification fee.
7. The failure to file a timely written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55678 and Contract Carrier Permit No. B-9813 or to

extend the suspension period may result in revocation of the certificate and the permit without further notice.

8. This Order is effective immediately on its Mailed Date.
