I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On May 27, 2003, Odd Lyngholm, doing business as American Wilderness Tours

(American Wilderness Tours), filed an application seeking authority to suspend operations under

Certificate of Public Convenience and Necessity (CPCN) PUC No. 55677S from May 15, 2003,

thorugh May 25, 2003.

2. American Wilderness Tours, under CPCN 55677S, may provide call-and-demand

limousine, charter, and sightseeing service between 875 Moraine Avenue, Estes Park, Colorado,

on the one hand, and Panorama Peak and points within three (3) miles of Panorama Peak,

Roosevelt National Forest, Colorado, on the other hand. In its request to suspend, American

Wilderness Tours states "Due to 2 feet of snow and ice on the last hill of Panorama Peak,

American Wilderness Tours is requesting a suspension of its operations under certificate of

public convenience and necessity PUC No. 55677S from May 15, 2003, through May 25, 2003.

American Wilderness Tours should have snow removal operations completed by May 25, 2003."

- 3. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on June 2, 2003. The Commission set this matter for hearing on July 2, 2003.
- 4. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 5. The information submitted with the application warrants the grant of the requested suspension.
- 6. The application for authority to suspend CPCN PUC No. 55677S is in the public interest.

II. ORDER

A. The Commission Orders That:

- 1. The hearing set for July 2, 2003, is vacated.
- 2. This application was deemed complete on July 2, 2003, within the meaning of § 40-6-109.5, C.R.S.
- The application filed by Odd Lyngholm, doing business as American Wilderness
 Tours, for authority to suspend operations under Certificate of Public Convenience and Necessity
 PUC No. 55677S is granted.
- 4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55677S is authorized from May 15, 2003 through May 25, 2003.

- 5. This Order is effective immediately on its Mailed Date.
