I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

- 1. On April 14, 2003, Alpine Activity Center, Inc., doing business as Steamboat Taxi, Inc., filed an application seeking authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 9742.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on April 21, 2003. The Commission set this matter for hearing on June 20, 2003.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. The information submitted with this application warrants the grant of the requested suspension.

5. The application for authority to suspend CPCN PUC No. 9742 is in the public interest.

II. **ORDER**

A. **The Commission Orders That:**

- 1. The hearing set for June 20, 2003, is vacated.
- 2. This application was deemed complete on June 11, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Alpine Activity Center, Inc., doing business as Steamboat Taxi, Inc., for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 9742 is granted.
- 4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 9742 is authorized from April 21, 2003 through October 21, 2003.
- 5. On or before September 22, 2003, Alpine Activity Center, Inc., doing business as Steamboat Taxi, Inc., shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 9742 or to extend the suspension period.
- 6. Prior to reinstatement, Alpine Activity Center, Inc., doing business as Steamboat Taxi, Inc., shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Alpine Activity Center, Inc., doing business as Steamboat Taxi, Inc., shall also pay the appropriate vehicle identification fee.
