## COMMISSION ORDER AUTHORIZING CERTAIN LOCAL EXCHANGE TELECOMMUNICATIONS PROVIDERS TO RECEIVE TRANSFERS FROM THE COLORADO LOW-INCOME TELEPHONE ASSISTANCE FUND FOR THE REPORTING YEAR 2002

## I. BY THE COMMISSION

#### A. Statement

1. The Colorado Low-Income Telephone Assistance Fund (LITAP) was established by the Colorado Legislature in 1990. *See* § 40-3.4-101 *et seq.*, C.R.S. In 1991, the Commission adopted Rules Prescribing the Procedures for Administering the Low-Income Telephone Assistance Fund. 4 *Code of Colorado Regulations* (CCR) 723-13. Pursuant to the Commission rules for the LITAP 4 CCR 723-5, the rules provide for the reimbursement of basic local exchange telecommunications providers from the LITAP Fund (Fund), as well as for the remittance of any excess collections by providers to the Fund. Rule 4 CCR 723-5.4 provides:

Upon collecting the uniform charge, each provider may retain, from the total charges collected, an amount sufficient to reimburse such provider for its provision of low-income telephone assistance. If the total collected is in excess of the amount sufficient to reimburse the provider, the provider shall credit the same to the Low-Income Telephone Assistance Fund. If the total collected is insufficient to reimburse the provider, the provider shall request reimbursement from the State Treasurer, who shall debit the same to the Low-Income Telephone Assistance Fund.

- 2. The Commission has established the Fund with the State Treasurer and is acting in the capacity of Administrator of the Fund. The Commission has received requests for reimbursement or reports of excess collections from providers of basic local exchange telecommunications services that have Low-Income Telephone Assistance Program Tariffs on file.
- 3. At its Weekly Meeting on June 16, 2003, the Commission discussed the review of the 2002 Annual Low-Income Telephone Program Reports. The review resulted in 23 telecommunications providers who will require reimbursement and 28 telecommunications providers who have collected in excess of the LITAP discounts.
- 4. The Commission reviewed the data reported by all LITAP providers for accuracy and completeness, and after adjustments find that the following providers shall receive reimbursement in the following amounts:

## II. ORDER

### **A.** The Commission Orders That:

- 1. The Commission, pursuant to § 40-3.4-108(1), C.R.S., and Rules 4 and 5 of the Commission's Rules Prescribing the Procedures for Administering the Low-Income Telephone Assistance Fund, 4 *Code of Colorado Regulations* 723-13, the providers listed in Section 4 in the Discussion part of this Order shall receive reimbursements totaling \$577,999.37 from the Colorado Low-Income Telephone Assistance Fund for calendar year 2002.
- 2. The providers listed in Section 5 of this Order will contribute an additional amount of \$43,000.79 for a total of \$230,190.81 collections in excess of expenses for the calendar year 2002.
- 3. The Commission may enter subsequent orders should the amounts in this Order change.
- 4. The 20-day time-period provided for by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration begins on the first day after the mailing of this Order.
  - 5. This Order is effective on its Mailed Date.
