I. <u>BY THE COMMISSION</u>

A. Statement

1. This matter concerns the Application by WWC Holding Company, a subsidiary of Western Wireless Corporation, for designation as an Eligible Telecommunications Carrier within certain areas served by CenturyTel of Eagle, Inc. A prehearing conference was conducted in this

matter on May 13, 2003 to set the procedural schedule on the Application.

2. According to the procedural schedule established at that prehearing conference, the parties were directed to file Direct Testimony on June 4, 2003; Answer Testimony on June 27, 2003; and Rebuttal and Cross-Answer Testimony on July 7, 2003. The Application was

3. All procedural schedules, other than the hearing date, determined at the May 13,


