> A. Statement

1. This matter comes before the Commission for Consideration of a Motion for

Enlargement of Time in Which to File Response filed by Commission Staff (Staff) on June 30,

2003. As grounds for its motion, Staff states that N.E. Colorado Cellular, Inc. (NECC), filed its

Motion for Clarification or in the Alternative, Motion to Reopen the Record. Responses to that

motion were due on June 30, 2003.

2. However, according to Staff, NECC failed to serve the motion on the Staff

member assigned to this docket. Staff represents that it only became aware of NECC's motion

on June 26, 2003. Staff further represents that due to the press of other business, it has been

unable to devote the time necessary to formulate an adequate response. Therefore, Staff seeks a

one-week enlargement of time until the close of business on Monday July 7, 2003 in which to file its response. Staff indicates that counsel for NECC, the Colorado Office of Consumer Counsel, and Qwest Corporation, all parties to this matter, do not oppose Staff's motion.

3. We find that good cause exists to grant Staff's motion for an enlargement of time to July 7, 2003 in which to file its response and waive response time.


## II. ORDER
