I. <u>BY THE COMMISSION:</u>

A. Statement

1. On June 13, 2003, University Services, Inc., doing business as Passenger Express

(Passenger Express), filed an application for temporary authority to extend operations under

Contract Carrier Permit No. B-9790 to include the transportation of passengers and their

baggage: between the Radisson Hotel Denver Stapleton Plaza, 3333 Quebec Street, Denver,

Colorado; Best Western Hotel Denver Stapleton, 3535 Quebec Street, Denver, Colorado, on the

one hand, and Denver International Airport, on the other hand. This application is restricted to

providing transportation services for the following named customers only: (1) Radisson Hotel

Denver Stapleton Plaza, 3333 Quebec Street, Denver, Colorado; and (2) Best Western Hotel

Denver Stapleton, 3535 Quebec Street, Denver, Colorado.

2. The Commission gave notice of the application on June 30, 2003.

3. There are no interventions opposing a grant of the application.

- 4. Pursuant to § 40-6-120(1), C.R.S., the Commission is authorized to grant temporary authority when "there appears to be an immediate and urgent need to any point or within a territory having no carrier service capable of meeting such need."
- 5. Passenger Express must meet a two-fold test: first, that there is an immediate and urgent need for the transportation services, and second, that there is no existing carrier capable of meeting the need. If Passenger Express fails to meet either test, the application must be denied.

B. Findings of Fact

6. Mike Bennett, the General Manager of the Radisson Hotel Denver Stapleton Plaza, and Kenny Martin, the General Manager of the Best Western Hotel Denver Stapleton, filed letters in support of this application. In his letter, Mr. Bennett states the Radisson Hotel has several unique transportation requirements that can be met by Passenger Express. The seven requirements named by Mr. Bennett that can be provided by Passenger Express are: (1) customized bus seating with seats spaced to the needs of the guests, airline passengers, pilots, and attendants; (2) seat belts on its buses, significantly enhancing the safety of those involved in bus travel, a feature not available from other carriers; (3) scheduled service provided seven days per week and 20.5 hours per day; (4) no interruption of service due to inclement weather; (5) guaranteed replacement of all equipment every 18 months; (6) drivers trained in the specific needs of the hotel; and (7) dispatch service available 24 hours per day. Mr. Bennett also states he has been unable to locate an alternative service provider that will meet the conditions and requirements of the service needed by the Radisson Hotel. Mr. Bennett further states "Currently the Radisson is providing airport transportation of its guests with its own fleet. However, because of required cost reductions after July 1, 2003, we will no longer be equipped to provide this service. We urgently need the service of Passenger Express immediately if we are to remain competitive in our marketplace."

7. In his letter Mr. Martin states "We need Passenger Express' services as they are unique and they have agreed to customize their services based on the needs of our company. The service to be provided by Passenger Express is critical to the daily operations of the Best Western Hotel." The customized services that Mr. Martin states Passenger Express has agreed to provide are similar to the services named by Mr. Bennett of the Radisson Hotel. Mr. Martin also states "[a]t one time, the Best Western attempted to provide airport transportation to its guests with its own fleet. However, the Best Western is no longer equipped to provide this service. As has already been stated we urgently need the service of Passenger Express if we are to remain competitive in our marketplace."

C. Conclusions

- 8. An immediate and urgent need for the requested transportation services has been shown to exist, and no other carrier has been shown to be capable of providing the service.
- 9. Passenger Express has adequate equipment and financial resources to begin immediate service within the scope of the authority sought.
 - 10. This application for temporary authority is in the public interest.
- 11. Passenger Express is advised that the grant of a temporary authority creates no presumption that a permanent authority will be granted.

II. **ORDER**

The Commission Orders That: A.

- 1. University Services, Inc., doing business as Passenger Express, is granted temporary authority to extend operations under Contract Carrier Permit No. B-9790 for a period of 150 days commencing from the Mailed Date of this Order, with authority as set forth in the Appendix.
- 2. University Services, Inc., doing business as Passenger Express, shall operate in accordance with all applicable Commission rules and regulations.
- 3. University Services, Inc., doing business as Passenger Express, shall not extend operations until it has filed the proper tariff and notice in writing has been received from the Commission that it is in compliance and may begin service.
- 4. If University Services, Inc., doing business as Passenger Express, does not comply with the requirements of this Order within 30 days of its effective date, then the temporary authority to extend operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 30 days.
- 5. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

- 6. This Order is effective immediately on its Mailed Date.
