A. Statement, Findings and Conclusions

- 1. On May 28, 2003, James B. Maloney, doing business as 3rd Street Transportation, filed an application seeking approval to abandon operations as a contract carrier by motor vehicle under Contract Carrier Permit No. A-9825.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on June 2, 2003. The Commission set this matter for hearing on July 30, 2003.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. The information submitted with this application warrants the grant of the requested abandonment.

II. ORDER

A. The Commission Orders That

- 1. The hearing set for July 30, 2003, is vacated.
- 2. This application was deemed complete on August 1, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by James B. Maloney, doing business as 3rd Street Transportation, for approval to abandon operations under contract carrier permit number A-9825 is granted.
