I. BY THE COMMISSION:

> A. **Statement, Findings and Conclusions**

1. On May 16, 2003, Admired Transportation, Inc., filed an application seeking

authority to suspend operations as a contract carrier by motor vehicle under permit number

B-9814.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on June 30, 2003. The Commission set this

matter for hearing on September 2, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

4. The information submitted with this application warrants the grant of the

requested suspension.

5. The application for authority to suspend contract carrier permit number B-9814 is in the public interest.

### II. **ORDER**

#### **The Commission Orders That:** A.

- 1. The hearing set for September 2, 2003, is vacated.
- 2. This application was deemed complete August 8, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Admired Transportation, Inc. for authority to suspend operations under contract carrier permit number B-9814 is granted.
- 4. The suspension of motor vehicle operations under contract carrier permit number B-9814 is authorized from June 27, 2003 through November 27, 2003.
- 5. On or before October 27, 2003, Admired Transportation, Inc. shall file a written request either to reinstate contract carrier permit number B-9814 or to extend the suspension period.
- 6. Prior to reinstatement, Admired Transportation, Inc. shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Admired Transportation, Inc. shall also pay the appropriate vehicle identification fee.
- 7. The failure to file a timely written request either to reinstate contract carrier permit number B-9814 or to extend the suspension period may result in revocation of the permit without further notice.

- 8. This Order is effective immediately on its Mailed Date.
