I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On June 25, 2003, David Carrel, doing business as Lift Ticket Limo, filed an

application seeking authority to suspend operations under Certificate of Public Convenience and

Necessity (CPCN) PUC No. 55715.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on June 30, 2003. The Commission set this

matter for hearing on September 5, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

4. The information submitted with this application warrants the grant of the

requested suspension.

5. The application for authority to suspend CPCN PUC No. 55715 is in the public interest.

II. **ORDER**

A. **The Commission Orders That:**

- 1. The hearing set for September 5, 2003, is vacated.
- 2. This application was deemed complete on August 8, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by David Carrel, doing business as Lift Ticket Limo, for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55715 is granted.
- 4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55715 is authorized from June 20, 2003 through November 27, 2003.
- 5. On or before October 27, 2003, David Carrel, doing business as Lift Ticket Limo, shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55715 or to extend the suspension period.
- 6. Prior to reinstatement, David Carrel, doing business as Lift Ticket Limo, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. David Carrel, doing business as Lift Ticket Limo, shall also pay the appropriate vehicle identification fee.
