I. <u>BY THE COMMISSION</u>

A. Statement of Findings and Fact

1. On July 3, 2003, AT&T Wireless Services of Colorado, LLC, Fort Collins-Loveland Cellular Telephone Company, and Greeley Cellular Telephone Company (collectively AT&T Wireless), filed an application for a waiver of the Colorado Public Utilities Commission's

(Commission) requirements found in Rule 4 Code of Colorado Regulations (CCR) 723-22-5.

AT&T Wireless is requesting a temporary waiver until January 5, 2004.

2. The grounds stated within this application are that AT&T Wireless is currently

going through the process of redesigning its system. In order to comply with Commission

Rule 4 CCR 723-22-5, AT&T Wireless represents that it needs to manually prepare the list and

implement a series of computer programs specifically for providing the Commission this

information. AT&T Wireless also states that it would be difficult to design new computer

programs while they are also in the process of implementing the new system changes. According

to AT&T Wireless, this would cause it to duplicate its efforts to ensure compliance.

AT&T Wireless also states that as soon as the new system is running, the specially developed

programs would be obsolete and useless, and that new programs would have to be developed and implemented on the redesigned system.

3. Now, being duly advised in the matter, the Commission finds that good cause has been stated and grants in full the application for the requested temporary waiver. A wavier of Rule 4 CCR 723-22-5 shall be granted until January 5, 2004.

## **A.** The Commission Orders That:


- 1. The waiver application is deemed complete.
