THE APPLICATION OF CHANDA L. JONES AND JOHN T. JONES, JR., DOING BUSINESS AS DELTA TRANSIT COMPANY, FOR AUTHORITY TO EXTEND OPERATIONS UNDER CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY PUC NO. 52100.

**COMMISSION ORDER GRANTING EXTENSION
TO CERTIFICATE OF PUBLIC CONVENIENCE
AND NECESSITY**

I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

1. On June 30, 2003, Chanda L. Jones and John T. Jones, Jr., doing business as Delta Transit Company (Delta Transit), filed an application for permanent authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 52100 to include the transportation of passengers and their baggage, in call-and-demand limousine service: (I) between all points in Delta County, State of Colorado; and (II) from all points in Delta County, State of Colorado, on the one hand, to all points within a 100-mile radius of the intersection of U.S. Highway 50 and Colorado Highway 92 in the City of Delta, on the other hand; with express authority to provide round-trip service, between points within the above described 100-mile radius, and points in Delta County so long as the service both originates and terminates in Delta County. Part II of this application is restricted as follows: (A) against providing service to or from either San Juan County or La Plata County, Colorado; and (B) against providing one-way "deadhead" or empty mileage service as part of round-trip service.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on July 14, 2003. The Commission set this matter for hearing on September 18, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is non-contested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants the grant of the requested authority.

5. The present or future public convenience and necessity requires, or will require, the transportation service as requested.

6. Delta Transit is ready, willing, and able properly to perform the service as requested.

7. This application for permanent authority is in the public interest.

II. ORDER

A. The Commission Orders That:

1. The hearing set for September 18, 2003, is vacated.
2. This application was deemed complete on August 21, 2003, within the meaning of § 40-6-109.5, C.R.S.
3. Chanda L. Jones and John T. Jones, Jr., doing business as Delta Transit Company, is authorized to extend operations under Certificate of Public Convenience and Necessity PUC

No. 52100 as follows: the transportation of passengers and their baggage, in call-and-demand limousine service: (I) between all points in Delta County, State of Colorado; and (II) from all points in Delta County, State of Colorado, on the one hand, to all points within a 100-mile radius of the intersection of U.S. Highway 50 and Colorado Highway 92 in the City of Delta, on the other hand; with express authority to provide round-trip service, between points within the above described 100-mile radius, and points in Delta County so long as the service both originates and terminates in Delta County. Part II of this application is restricted as follows: (A) against providing service to or from either San Juan County or La Plata County, Colorado; and (B) against providing one-way "deadhead" or empty mileage service as part of round-trip service.

4. The complete authority under Certificate of Public Convenience and Necessity PUC No. 52100, as extended, shall be as set forth in the Appendix.

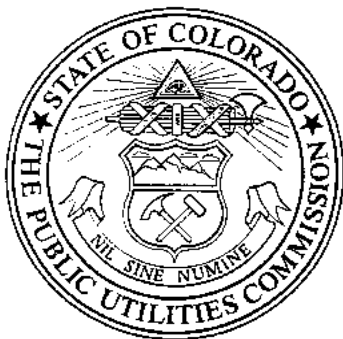
5. Chanda L. Jones and John T. Jones, Jr., doing business as Delta Transit Company, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Chanda L. Jones and John T. Jones, Jr., doing business as Delta Transit Company, shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Chanda L. Jones and John T. Jones, Jr., doing business as Delta Transit Company, may not begin the extended operations until these requirements have been met and notice in writing has been received from the Commission stating it is in compliance and may begin service.

6. If Chanda L. Jones and John T. Jones, Jr., doing business as Delta Transit Company, does not comply with the requirements of this Order within 60 days of its effective date, then the authority to conduct operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.

7. This Order is effective immediately on its Mailed Date.

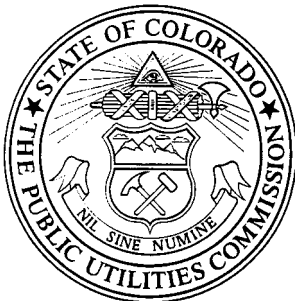
