I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On May 16, 2003, Ramblin' Express, Inc. doing business as Rocky Mountain

Limousine, Inc., filed an application seeking authority to suspend operations under a portion,

Item III, of Certificate of Public Convenience and Necessity (CPCN) PUC No. L275 from July

21, 2003 through January 21, 2004. The portion, Item III, of CPCN PUC No. L275 to be

suspended authorizes the transportation of passengers and their baggage in scheduled service

between the Broadmoor Hotel, 10 Lake Circle, Colorado Springs, Colorado, on the one hand, and

points within Colorado Springs, Colorado, on the other hand. Item III is restricted to providing

service for only employees of the Broadmoor Hotel.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on June 2, 2003. The Commission set this matter

for hearing on August 6, 2003.

- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. The information submitted with this application warrants the grant of the requested partial suspension.
- 5. The application for authority to suspend operations under a portion of CPCN PUC No. L275 is in the public interest.

## II. **ORDER**

## Α. **The Commission Orders That:**

- 1. The hearing set for August 6, 2003, is vacated.
- 2. This application was deemed complete on August 27, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Ramblin' Express, Inc., doing business as Rocky Mountain Limousine, Inc., for authority to suspend operations from July 21, 2003 through January 21, 2004, under a portion, Item III, of Certificate of Public Convenience and Necessity PUC No. L275 is granted.
- 4. The suspension of motor vehicle operations under Item III of Certificate of Public Convenience and Necessity PUC No. L275 is authorized from July 21, 2003 through January 21, 2004.
- 5. On or before December 22, 2003, Ramblin' Express, Inc. doing business as Rocky Mountain Limousine, Inc. shall file a written request either to reinstate the suspended portion of

Certificate of Public Convenience and Necessity PUC No. L275 or to extend the suspension period.

- 6. The failure to file a written request either to reinstate the suspended portion of Certificate of Public Convenience and Necessity PUC No. L275 or to extend the suspension period on or before December 22, 2003 may result in revocation of the suspended portion of the certificate without further notice.
