- 1. Correct Decision No. C03-1097 by inserting "OR COMPETITIVE LOCAL EXCHANGE CARRIERS" in the caption to show that this decision and docket pertain to certain competitive local exchange carriers as well as certain emerging competitive telecommunications service providers.
- 2. Correct Decision No. C03-1097 in the first sentence of ¶ I.A.1. by inserting "or competitive local services" after "jurisdictional emerging competitive telecommunications services" so that ¶ I.A.1. reads:
 - 1. Those entities listed on Attachment A resell jurisdictional emerging competitive telecommunications services **or competitive local services** to Colorado consumers. *See generally*, §§ 40-15-301 and 302, C.R.S.

3. Correct Decision No. C03-1097 in ¶ I.A.3. by inserting "or competitive local exchange services" after "Providers of jurisdictional emerging competitive telecommunications services" so that ¶ I.A.3. reads:

- 3. Providers of jurisdictional emerging competitive telecommunications services **or competitive local exchange services** are required, pursuant to § 40-3-110, C.R.S., and 4 *Code of Colorado Regulations* (CCR) 723-1-25(a)(1), to file an annual report with the Colorado Public Utilities Commission on or before April 30 of each year for the preceding calendar year.
- 4. Correct the Order of Decision No. C03-1097 ¶ II.A.1.:
 - by inserting "emerging competitive" before "local exchange service provider" and
 - by inserting "and competitive local exchange carrier" before "listed on Attachment A"

so that ¶ II.A.1. reads:

- 1. Consistent with the above discussion each **emerging competitive** local exchange service provider **and competitive local exchange carrier** listed on Attachment A shall appear before the Commission to show cause why the Commission should not take action and enter an order including but not be limited to, an order to cease and desist; an order that amends or revokes the provider's certificate of public convenience and necessity, including the revocation of applicable tariffs; an order that restricts the provider's ability to connect with local exchange service providers; an order that contains a combination of the forgoing remedial actions; and/or an order that requires any other corrective or remedial action which the Commission deems appropriate.
- 5. Further, in Decision No. C03-1097, use "Staff" for Staff of the Colorado Public Utilities Commission, after its first occurrence in the discussion and the Order.
 - 6. Attached is a corrected Decision No. C03-1097.
