**I. BY THE COMMISSION:**

**A. Statement, Findings and Conclusions**

1. On September 5, 2003, Arrow Express, LLC, filed an application for permanent authority to extend operations under Contract Carrier Permit No. B-9856 to include the transportation of passengers and their baggage, between all points in Counties of Adams, Arapahoe, Boulder, Denver, Douglas and Jefferson, State of Colorado. This application is restricted to providing transportation services for: (1) Marycrest Assisted Living, 2850 Columbine Road, Denver, Colorado 80221; (2) Park Hill Assisted Living Center, 1901 Eudora Street, Denver, Colorado 80220; and (3) HealthOne Alliance, Johnson Adult Day Program, 3444 South Emerson Street, Englewood, Colorado 80110.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on September 8, 2003. The Commission set this matter for hearing on November 14, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is non-contested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants the grant of the requested authority.

5. A present and special need for the requested transportation services exists. A grant of the requested authority will not impair the efficient public service of any authorized common carrier providing a similar service.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The hearing set for November 14, 2003, is vacated.
2. This application was deemed complete on October 15, 2003, within the meaning of § 40-6-109.5, C.R.S.
3. Arrow Express, LLC, is authorized to extend operations under Contract Carrier Permit No. B-9856 as follows: Transportation of passengers and their baggage, between all points in Counties of Adams, Arapahoe, Boulder, Denver, Douglas and Jefferson, State of Colorado. Restricted to providing transportation services for: (1) Marycrest Assisted Living, 2850 Columbine Road, Denver, Colorado 80221; (2) Park Hill Assisted Living Center, 1901 Eudora Street, Denver, Colorado 80220; and (3) HealthOne Alliance, Johnson Adult Day Program, 3444 South Emerson Street, Englewood, Colorado 80110.

4. The complete authority under Contract Carrier Permit No. B-9856, as extended, shall be as set forth in the Appendix and this Order is a PERMIT.

5. Arrow Express, LLC, as the holder of Contract Carrier Permit No. B-9856, shall operate in accordance with all applicable Commission rules and regulations.

6. Arrow Express, LLC, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Arrow Express, LLC, shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Arrow Express, LLC, may not begin extended operations until these requirements have been met and it has received notice in writing from the Commission that it is compliance and may begin service.

7. If Arrow Express, LLC, does not comply with the requirements of this Order within 60 days of its effective date, then the authority to extend operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.

8. This Order is effective immediately on its Mailed Date.

Transportation of passengers and their baggage:

(I) Between all points in the Counties of Adams, Arapahoe, Boulder, Denver, Douglas, and Jefferson, State of Colorado.

Item (I) is restricted as follows:

- (1) To providing transportation service for (A) Jefferson County Division of Human Services, 900 Jefferson County Parkway, Golden, Colorado 80401; (B) City & County of Denver Department of Human Services, 1200 Federal Boulevard, Denver, Colorado 80204; (C) Arapahoe/Douglas Mental Health Network, 5500 South Sycamore Street, Suite #303, Littleton, Colorado 80120; and (D) Arapahoe County Community Services Department, 2009 West Littleton Boulevard, Littleton, Colorado 80120;
- (2) To the transportation of clients of the entities named in Restriction (I) above;
- (3) Against the transportation of persons 17 years of age or younger, unless said persons are the companions of carrier's passengers;
- (4) Against the pick-up or drop-off of passengers at Denver International Airport, Denver, Colorado;
- (5) Service to, from or between points in Jefferson County, Colorado, is restricted to the transportation of passengers to and from medical and other treatment facilities for the purpose of treatment; and
- (6) To the use of eight or fewer vehicles.

(II) Between all points in Counties of Adams, Arapahoe, Boulder, Denver, Douglas and Jefferson, State of Colorado.

Item (II) is restricted to providing transportation services for: (1) Marycrest Assisted Living, 2850 Columbine Road, Denver, Colorado 80221; (2) Park Hill Assisted Living Center, 1901 Eudora Street, Denver, Colorado 80220; and (3) HealthOne Alliance, Johnson Adult Day Program, 3444 South Emerson Street, Englewood, Colorado 80110.
