I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On September 19, 2003, Florence M. Barajas doing business as Your Ride

Transportation Services filed an application seeking authority to suspend operations under

Certificate of Public Convenience and Necessity (CPCN) PUC No. 55039.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on October 6, 2003. The Commission set this

matter for hearing on November 14, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

4. The information submitted with this application warrants the grant of the

requested suspension.

5. The application for authority to suspend CPCN PUC No. 55039 is in the public interest.

II. **ORDER**

A. **The Commission Orders That:**

- 1. The hearing set for November 14, 2003, is vacated.
- 2. This application was deemed complete on October 29, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Florence M. Barajas doing business as Your Ride Transportation Services for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55039 is granted.
- 4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55039 is authorized from September 18, 2003 through March 31, 2004.
- 5. On or before March 1, 2004, Florence M. Barajas doing business as Your Ride Transportation Services shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55039 or to extend the suspension period.
- 6. Prior to reinstatement, Florence M Barajas doing business as Your Ride Transportation Services shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Florence M. Barajas doing business as Your Ride Transportation Services shall also pay the appropriate vehicle identification fee.
