I. **BY THE COMMISSION**

> Α. Statement

1. On October 17, 2003, Eastern Colorado Utility Company (Eastern) filed its

application for waiver of Rule 4 Code of Colorado Regulations (CCR) 723-8-2.2 of the

Commission's Gas Cost Adjustment Rules. Eastern, in its application, seeks a waiver pursuant to

Commission Rule 4 CCR 723-8-11, of the requirement that Eastern file its annual Gas Cost

Adjustment (GCA) Application (Application) no later than two weeks in advance of a proposed

November 1, 2003 effective date.

2. In Decision No. C03-1006, the Commission approved an application of Eastern for

an out-of-period adjustment to its GCA rate, effective September 25, 2003. Eastern stated in its

Application, that it would forgo a further adjustment in its GCA rate from that granted in

Decision No. C03-1006.

3. Eastern's Application shows that the requirement to file an application for an

identical rate is unwarranted and that a waiver should be granted. A waiver of the Rules in regard

to Eastern's GCA will reduce the economic burden of regulation and will serve the public interest.

4. We find that good cause has been stated for the requested waiver, and will grant the Application.

II. ORDER

A. The Commission Orders That:

- 1. The Application filed by Eastern Colorado Utility Company for a waiver of Rule 4 *Code of Colorado Regulations* 723-8-2.2 of the Commission's Gas Cost Adjustment Rules is granted.
- 2. Eastern Colorado Utility Company shall not be required to file a 2003 annual Gas Cost Adjustment Application to be effective November 1, 2003.
 - 3. The Commission will waive response time to the motion.
 - 4. This Order is effective on its Mailed Date.
