A. Statement, Findings, and Conclusions

Company) filed a Motion for Thirty Day Extension of Time to File Updated Class Allocations (Motion for Extension). Public Service states that under the settlement agreement reached in this case and approved in Decision No. R99-678, the Company is required to file annually on November 1, the class allocations used to design the Air Quality Improvement Rider (AQIR)

Regulatory Commission (FERC) approval to collect a portion of the AQIR costs from its wholesale customers. Public Service did apply to the FERC for such cost recovery in FERC

Docket ER03-971-000. Within the Motion for Extension, the Company states it is hopeful that a

settlement can be reached in this FERC docket during November 2003. If a settlement is

reached, it is likely that the AQIR rate for retail customers will be reduced and Public Service

wishes to take this reduction into account in proposing the 2004 AQIR rates.

3. Public Service states that it has served the motion on all persons on the Company's service lists for both of the AQIR dockets, Docket Nos. 98A-511E and 02S-485E. The Commission waives the remaining response time to the Motion for Extension in order to timely address the merits of the motion.

4. The Commissions finds that good cause has been shown to grant the Motion for Extension. In particular, a possible reduction in the AQIR rate for retail customers (as a result of a settlement in the FERC proceeding) states good cause.
