### A. Statement, Findings and Conclusions

- 1. On October 6, 2003, Odd Lyngholm, doing business as American Wilderness Tours, filed an application seeking authority to temporarily suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55677S from October 4, 2003, through October 15, 2003.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on October 27, 2003. The Commission set this matter for hearing on December 2, 2003.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
