I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

1. On October 15, 2003, MTV Group, LLC (MTV Group), filed an application for permanent authority to conduct operations as a common carrier by motor vehicle for hire for the transportation of passengers and their baggage, in scheduled service, between the Aurora Mall, 14200 East Alameda Avenue, Aurora, Colorado, on the one hand, and the Colorado Convention Center, 700 14th Street, Denver, Colorado, on the other hand, with service to all intermediate points on a route beginning at the Aurora Mall; then east on Alameda Avenue to its intersection with Sable Boulevard; then north on Sable Boulevard to its intersection with 6th Avenue; then east on 6th Avenue to its intersection with Chambers Road; then north on Chambers Road to its intersection with Colfax Avenue; then west on Colfax Avenue to its intersection with 15th Street; then northwest on 15th Street to its intersection with Champa Street; then southwest on Champa Street to its intersection with 14th Street; then southeast on 14th Street to its intersection with Colfax Avenue; then east on Colfax Avenue to its intersection with Chambers Road; then south on Chambers Road to its intersection with 6th Avenue; then west on 6th Avenue to its

intersection with Sable Boulevard; then south on Sable Boulevard to its intersection with Alameda Avenue; then east on Alameda Avenue to the point of beginning.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on October 20, 2003. The Commission set this matter for hearing on December 17, 2003.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants the grant of the requested authority.

5. The present or future public convenience and necessity requires, or will require, the transportation service as requested.

6. MTV Group, LLC, is ready, willing, and able properly to perform the service as requested.

7. This application for permanent authority is in the public interest.

II. ORDER

A. The Commission Orders That:

1. The hearing set for December 17, 2003, is vacated.
2. This application was deemed complete on November 24, 2003, within the meaning of § 40-6-109.5, C.R.S.

3. MTV Group, LLC, is granted a Certificate of Public Convenience and Necessity to operate as a common carrier by motor vehicle for hire with authority as set forth in the Appendix.

This Order is a CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY.

4. MTV Group, LLC, shall operate in accordance with all applicable Commission rules and regulations.

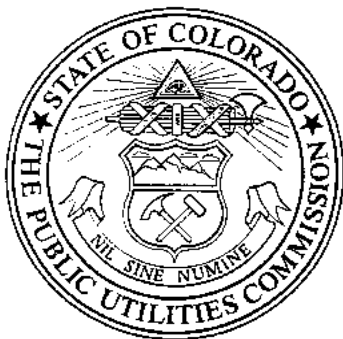
5. MTV Group, LLC, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. MTV Group, LLC, shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. MTV Group, LLC, may not begin operations until these requirements have been met and notice in writing has been received from the Commission.

6. If MTV Group, LLC, does not comply with the requirements of this Order within 60 days of its effective date, then the authority to conduct operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.

7. This Order is effective immediately on its Mailed Date.
