**I. BY THE COMMISSION**

**A. Statement**

1. On October 15, 2003, Kinder Morgan, Inc. (KMI), filed Advice Letter Nos. 201 and 202. Pursuant to § 40-6-111(1), C.R.S., we suspended the effective date of the proposed tariffs attached to the Advice Letters for an initial 120-day period and set the matters for hearing. *See* Decision Nos. C03-1301 and C03-1303, effective November 26, 2003.

2. In Decision Nos. C03-1301 and C03-1303, we set a prehearing conference in these matters for December 1, 2003 at 1:30 p.m. in Commission Hearing Room A. Neither KMI, nor Commission Staff was represented at the prehearing conference. It appears that due to the Thanksgiving Holiday, the parties to this matter failed to receive our Order setting the prehearing conference in a timely manner. Also, the notice periods for intervention as provided in Decision Nos. C03-1301 and C03-1303 run beyond the desired date for a prehearing conference

for addressing these matters. Therefore, we will shorten the notice period from the original 30 days given for intervention in Decision Nos. C03-1301 and C03-1303 to December 10, 2003.

3. Since Commission procedures in each of these dockets is similar, as well as the issues to be addressed, we will consolidate Docket Nos. 03S-503G and 03S-504G to address these matters together.

4. We will continue the prehearing conference to Monday December 12, 2003. This should provide sufficient notice to the parties of the rescheduled hearing date.

## **II. ORDER**

### **A. The Commission Orders That:**

1. Any person, firm, or corporation, including any who have previously filed a document protesting the proposed tariffs, who desire to intervene and participate as a party in this proceeding shall file a motion to intervene with the Commission on or before December 10, 2003, and shall serve a copy of the motion on Kinder Morgan, Inc.'s attorney of record.

2. The prehearing conference originally scheduled for December 1, 2003 shall be continued as follows:
