I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On October 22, 2003, Sidney Brasfield, doing business as All Around Taxi (All

Around Taxi), filed an application for permanent authority to conduct operations as a common

carrier by motor vehicle for hire for the transportation of passengers and their baggage, in taxi

service, between all points in Moffat County, State of Colorado, and between said points, on the

one hand, and the Hayden Airport and all points in Hayden, Colorado, on the other hand.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on October 27, 2003. The Commission set this

matter for hearing on January 6, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

- 4. The information submitted with this application warrants the grant of the requested authority.
- 5. The present or future public convenience and necessity requires, or will require, the transportation service as requested.
- 6. All Around Taxi is ready, willing, and able to properly perform the service as requested.
 - 7. This application for permanent authority is in the public interest.

II. ORDER

A. The Commission Orders That:

- 1. The hearing set for January 6, 2004, is vacated.
- 2. This application was deemed complete on December 3, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. All Around Taxi, is granted a Certificate of Public Convenience and Necessity to operate as a common carrier by motor vehicle for hire with authority as set forth in the Appendix. This Order is a CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY.
- 4. All Around Taxi, shall operate in accordance with all applicable Commission rules and regulations.
- 5. All Around Taxi, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. All Around Taxi, shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. All Around Taxi, may not begin operations until

it has met these requirements and notice in writing has been received from the Commission stating it is in compliance and may begin service.

- 6. If All Around Taxi, does not comply with the requirements of this Order within 60 days of its effective date, then the authority to conduct operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.
 - 7. This Order is effective immediately on its Mailed Date.
