I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On October 22, 2003, Anlance Protection, Ltd., (Anlance) filed an application

seeking authority to suspend operations under Certificate of Public Convenience and Necessity

(CPCN) PUC No. 55678 and Contract Carrier Permit No. B-9813.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on October 27, 2003. The Commission set this

matter for hearing on January 8, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

4. The information submitted with this application warrants granting of the requested

suspension.

5. The application for authority to suspend CPCN PUC No. 55678 and Permit No. B-9813 is in the public interest.

II. **ORDER**

The Commission Orders That: Α.

- 1. The hearing set for January 8, 2004, is vacated.
- 2. This application was deemed complete on December 10, 2003, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Anlance, for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55678 and Contract Carrier Permit B-9813 is granted.
- 4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55678 and Contract Carrier Permit B-9813 is authorized from October 19, 2003 through April 19, 2004.
- 5. On or before March 22, 2004, Anlance, shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55678 and Contract Carrier Permit No. B-9813, or to extend the suspension period.
- 6. Prior to reinstatement of the CPCN or Contract Carrier Permit, Anlance, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Anlance, shall also pay the appropriate vehicle identification fee.
- 7. The failure to file a timely written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55678 and Contract Carrier Permit No. B-9813, or to

extend the suspension period may result in revocation of the certificate and permit without further notice.
