I. BY THE COMMISSION

A. Statement

- 1. On November 25, 2003, Qwest Corporation (Qwest) and Qwest Services Corporation (QSC) filed an application to execute a transfer stock of Qwest Wireless, LLC (QW) from Qwest to QSC pursuant to 4 *Code of Colorado Regulations* 723-25-8.
- 2. QW is a wholly-owned subsidiary of Qwest. Qwest is a wholly-owned subsidiary of QSC. As a result of the transaction, QW will become a wholly-owned subsidiary of QSC.
- 3. At the Commissioners' Weekly Agenda Meeting on November 26, 2003, by minute entry the Commission granted the request for a shortened notice period to ten days. Notice of the application was posted on the Commission's web site on November 26, 2003. Interventions were due on or before December 8, 2003. None were filed.

B. Discussion

4. The application is unopposed and may be considered without a hearing. § 40-6-109(5), C.R.S.

5. The Commission finds that the proposed transfer of assets is not contrary to the public interest.

- 1. The application by Qwest Corporation and Qwest Services Corporation is deemed complete.
 - 2. The application to approve the transfer of Qwest Wireless, LLC is granted.
- 3. The obligation of Qwest Wireless, LLC to file an annual report with the Commission and contribute to all applicable Colorado funds for the period prior to the effective date of this Order remains. These funds include the Public Utilities Commission's Fixed Utilities Fund, the Colorado High Cost Administration Fund, the Telecommunications Relay Services for the Disabled Telephone Users Program, and the Emergency Telephone Access Act Program.
 - 4. This Order is effective upon its Mailed Date.
