I. STATEMENT

- 1. On January 29, 2003, Michael L. Glaser, Esq. (Glaser) filed a pleading entitled "Motion for Leave to File Michael L. Glaser's Motion to Strike Written Testimony Late and Enlargement of Time Period in Which to File Said Motion" (Motion) in the captioned proceeding. The Motion seeks an enlargement of time, up to and including 10:00 a.m. on January 29, 2003, to submit a motion to strike testimony previously filed by the Staff of the Colorado Public Utilities Commission (Staff) and Mile High Telecom Partners, LLP (Mile High). Decision No. R02-1427 imposed a deadline for such a motion to strike of January 28, 2003.
- 2. On January 30, 2003, the undersigned advised counsel for Staff and Mile High telephonically that the response time to the Motion would be shortened to noon on January 31, 2003.

3. Counsel for Staff and Mile High have advised the undersigned that they do not intend to submit a response to the Motion.

4. The Motion indicates that a ministerial error on the part of Glaser's counsel resulted in the failure to file Glaser's motion to strike testimony on January 28, 2003. Such a motion to strike was filed on the morning of January 29, 2003. The Motion states good cause for the nominal enlargement of time requested. Neither Staff nor Mile High will be prejudiced by a grant of the extension. Therefore, the Motion will be granted.

 Michael L. Glaser, Esq. in the captioned proceeding, is granted.
