INTERIM ORDER OF ADMINISTRATIVE LAW JUDGE DALE E. ISLEY GRANTING MOTION TO RESTRICTIVELY AMEND APPLICATION

I. STATEMENT

1. On January 30, 2003, Owner/Driver United Corporation (Owner/Driver), Boulder Express, LLC (Boulder Express), and Golden West Commuter, LLC (Golden West), filed a pleading entitled "Stipulation of Parties Motion to Restrictively Amend Application and to

Withdraw Intervention" (Golden West Stipulation) in the captioned dockets. The Golden West Stipulation requests that the temporary authority granted to Owner/Driver in Decision No. C02-1003 (hereinafter, the temporary authority) be restrictively amended as set forth in Exhibit 26-A attached to the Golden West Stipulation.¹

- 2. The Golden West Stipulation indicates that the intervention previously filed by Golden West in the captioned dockets may be deemed withdrawn upon Commission approval of the restrictive amendments set forth therein.
- 4. Review of the restrictive amendments set forth in the Golden West Stipulation reveal that they are restrictive in nature, clearly stated, and enforceable. Such amendments will, therefore, be accepted and approved and the intervention previously filed in these matters by Golden West may be deemed withdrawn. The scope of the temporary authority, as further amended by the Golden West Stipulation, is set forth on Appendix A attached hereto.

II. ORDER

A. It Is Ordered That:

- 1. The Stipulation of Parties Motion to Restrictively Amend Application and to Withdraw Intervention filed by Owner/Driver United Corporation, Boulder Express, LLC, and Golden West Commuter, LLC in the captioned proceeding is granted.
- 2. The intervention previously filed in the captioned proceedings by Golden West Commuter, LLC, is withdrawn.

¹ The scope of the temporary authority originally granted in Decision No. C02-1003 was modified by Decision Nos. C02-1220 and C02-1415 and by certain restrictive amendments between Metro Taxi, Inc., Owner/Driver and Boulder Express. *See*, Decision No. C03-0103. The Commission previously approved the temporary lease of the temporary authority from Owner/Driver to Boulder Express. *See*, Decision No. C02-1195.
