I. STATEMENT

- 1. On January 31, 2003, Greater Colorado Springs Transportation Company, Inc., doing business as Yellow Cab Company of Colorado Springs *et al.* (GCST) and RDS Transportation, Ltd., doing business as Yellow Cab of Colorado Springs (RDS) filed a Joint Motion: (1) to amend and/or supplement pleading entitled "Intervention and Entry of Appearance by Right of Greater Colorado Springs Transportation Company, DBA Yellow Cab Company of Colorado Springs *et al.*, in Opposition to the Application, Alternative Petition for Permissive Intervention, and Preliminary List of Witnesses and Exhibits" filed on September 26, 2002, and to permit addition of RDS LTD as a Joint Intervenor at the hearing on February 12, 2003; (2) Request for Shortened Response Time; and (3) Request for Expedited Action.
- 2. Movants request the above action since RDS is in the process of purchasing certain assets of GCST, including Certificate of Public Convenience and Necessity PUC No. 109.

Movants state that RDS received approval to purchase Certificate No. 109 by Decision No. C02-1277 (November 14, 2002), and that the transaction is tentatively set to close no later than February 10, 2003.

3. The Joint Motion will be granted. Response time is waived.

II. ORDER

A. It Is Ordered That:

- 1. The joint motion of Greater Colorado Springs Transportation Company, doing business as Yellow Cab Company of Colorado Springs *et al.*, and RDS Transportation, Ltd., doing business as Yellow Cab Company of Colorado Springs to amend and/or supplement pleading entitled "Intervention and Entry of Appearance by Right of Greater Colorado Springs Transportation, DBA as Yellow Cab Company of Colorado Springs *et al.*, in Opposition to the Application, Alternative Petition for Permissive Intervention, and Preliminary List of Witnesses and Exhibits" filed on September 26, 2002, and to permit addition of RDS Transportation, Ltd. as a Joint Intervenor is granted.
 - 2. Response time to the motion is waived.
 - 3. This Order is effective immediately.
