The principal purpose of this filing is to place into effect in the Company's Colorado P.U.C. No. 6 a General Rate Schedule Adjustment II ("GRSA II") to become effective on January 29, 2004. The GRSA II rider, a positive 9.60 percent reflected on Original Sheet No. 105, will apply to base rates for all customers receiving electric power and energy under the Company's electric tariffs. This filing also complies with the Settlement Agreement entered into in the Company's last general rate case, Docket No. 02S-594E, and with Decision No. C03-0697 in which the Commission approved the Settlement Agreement.

The proposed GRSA II rider, a positive 9.60 percent, will result in an annual increase in the Company's base electric rates of \$11,358,847 based upon the revenue requirements for the test year ending August 31, 2003. The primary reason for the increase in electric rates through the GRSA II is to reflect the Company's current cost of providing electric services to its customers. This revenue requirement includes adjustments necessary to reflect the increasing cost of providing electric service. The cost increases include both capital costs and operating expenses. Implementation of the GRSA II contained in this filing will allow the Company to increase its electric revenue and provide it the opportunity to earn a 10.75 percent return on equity and a 9.07 percent return on rate base, which were established by the Commission in Decision No. C03-0697 in Docket No. 02S-594E.

In total this filing, if approved by the Public Utilities Commission, will increase the Company's overall base electric rates by \$11,358,847 or 9.13 percent. The Company has filed direct testimony and exhibits with the Public Utilities Commission in support of the need for this limited rate increase.
