# ORDER FURTHER SUSPENDING EFFECTIVE DATE OF TARIFFS

## I. BY THE COMMISSION

#### A. Statement

- 1. By Ordering Paragraph No. 1 in Decision No. C03-1423, the effective date of the tariff sheets filed by Aquila Networks WPC (Aquila) on December 1, 2003 under its Advice Letter No. 586 was suspended for 120 days, until April 30, 2004. By Decision No. C04-0382 the effective date of the tariff sheets was suspended an additional 90 days, until July 29, 2004, pursuant to § 40-6-111(1)(b), C.R.S. Further, in that decision we advised Aquila that it may be necessary to file an amendment to its Advice Letter No. 586 to change the effective dates of its proposed tariffs to allow the Commission to issue a decision in this matter by September 3, 2004 without exceeding the 210-day suspension period for the tariffs.<sup>1</sup>
- 2. On June 8, 2004, Aquila filed an amendment to Advice Letter No. 586 changing the effective date of the tariffs to allow a decision to be issued later than July 29, 2004.

# **B.** Findings of Fact

3. The Commission has agreed to issue a decision in this matter by September 3, 2004 (*see* Decision No. C04-0176). We now further suspend the effective date of these tariffs until September 3, 2004.

# II. ORDER

### **A.** The Commission Orders That:

- 1. The effective date of the tariff sheets filed by Aquila, Inc., doing business as Aquila Networks WPC, on December 1, 2003 under its Advice Letter No. 586, as modified by Amended Advice Letter No. 586, filed June 8, 2004 is further suspended until September 3, 2004.
  - 2. This Order is effective on its Mailed Date.
