DOING BUSINESS AS STEAMBOAT TAXI, INC. TO LISA ADAMO.

I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

- 1. On August 31, 2004, Alpine Activity Center, Inc. doing business as Steamboat Taxi, Inc. (Steamboat Taxi), record owner of Certificate of Public Convenience and Necessity (CPCN) PUC No. 9742, filed an application to permit Marty Waldron and Jimmy Waldron to transfer all of their issued and outstanding shares of capital stock in Steamboat Taxi to Lisa Adamo.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on September 7, 2004. The Commission set this matter for hearing on November 12, 2004.

- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. The information submitted with this application warrants granting the requested transfer all of the issued and outstanding shares of capital stock in Steamboat Taxi from Marty Waldron and Jimmy Waldron to Lisa Adamo.
 - 5. The financial standing of Lisa Adamo has been satisfactorily established.
- 6. Lisa Adamo, as a controlling shareholder of Steamboat Taxi, is ready, willing, and able to properly perform the duties to ensure continued adequate operations under CPCN PUC No. 9742.
- 7. This application to permit Marty Waldron and Jimmy Waldron to transfer all of their issued and outstanding shares of capital stock in Steamboat Taxi to Lisa Adamo is in the public interest.

II. ORDER

A. The Commission Orders That

- 1. The hearing set for November 12, 2004, is vacated.
- 2. This application was deemed complete on October 14, 2004, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Steamboat Taxi to permit Marty Waldron and Jimmy Marty Waldron to transfer all of their issued and outstanding shares of capital stock of Steamboat Taxi, record owner of Certificate of Public Convenience and Necessity PUC No. 9742 to Lisa Adamo is granted.

- 4. Lisa Adamo may not consummate the approved stock purchase transaction until (1) Steamboat Taxi has filed delinquent reports, if any, covering operations under the certificate up to the consummation of the stock transfer, and (2) an acceptance of stock transfer signed by Marty Waldron, Jimmy Waldron, and Lisa Adamo is filed with the Commission.
- 5. If Marty Waldron, Jimmy Waldron, and Lisa Adamo do not comply with the requirements of this Order within 60 days of its effective date, then the approval to transfer stock of Steamboat Taxi, record owner of CPCN PUC No. 9742, shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.
- 6. The 20-day time-period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, re-argument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

- 7. This Order is effective on its Mailed Date.
