- 1. On May 28, 2004, the Colorado Department of Transportation (CDOT) filed an application requesting authority to upgrade seven (7) grade-separated rail crossings of the Union Pacific Railroad (UPRR) in order to accommodate the reconstruction of I-25 within the City of Colorado Springs, Colorado.
- 2. The Commission gave notice of this application to all interested parties, including adjacent property owners in accordance with § 40-6-108(2), C.R.S. The Notice was mailed June 24, 2004.
- 3. On July 30, 2004, the UPRR filed an Entry of Appearance and Notice of Intervention.

determination of its merits, including the status of the final contract between the parties for

construction and maintenance of the crossing.
