Trial Staff of the Commission ("Staff") and Jonathan Levine dba Vail Luxury Limo ("Respondent") enter into this Stipulation and request that the Commission issue an order approving its terms as a complete resolution of all issues in this docket. In support of the within Stipulation, Staff and Respondent state:

1. On November 5, 2003, Civil Penalty Assessment Notice No. 28377-CPAN ("CPAN") was issued to Respondent by Commission Investigator, Reinhard A. Wolf.

In the CPAN, Respondent was charged with one violation of 40-16-103 CRS for offering services pursuant to this Article without being registered with the public utilities commission.

The total amount of the CPAN is \$1,100.00. A copy of the CPAN is attached as Appendix A, and by reference incorporated herein.

2. Background. Respondent previously held a registration with the commission under permit number LL-01228. This permit, or registration, was subsequently revoked due lack of proper insurance on file with the commission. This occurred on May 1, 2003.

On November 1, 2003, Investigator Wolf proceeded to the Vail, Colorado area in response to an informal complaint filed by another carrier. While in Vail, Wolf was able to have Respondent contacted by phone, obtain a commitment on price to be charged, and witness Respondent appear and offer services to Wolf.

The vehicle in question had qualified as a luxury limousine under Respondent's previous registration.

Investigator Wolf was directed by Safety and Compliance Supervisor Robert Laws to issue the CPAN to the Respondent for the violation covered in this CPAN. The CPAN was issued in person to the Respondent upon Respondent's appearance at the commission on November 5, 2003. Respondent then proceeded to obtain the proper registration on the same day.

- 3. Staff and Respondent desiring to compromise and settle the charge contained in this CPAN, HEREBY STIPULATE AND AGREE AS FOLLOWS:
- a. Respondent admits to the violation as contained in Civil Penalty Assessment No. 28377-CPAN, totaling \$1,100.00.
- b. Respondent agrees to cooperate, and has indeed already has cooperated, with Staff by promptly registering his luxury limousine operation.
- c. In consideration of Respondent's admissions in subparagraph (3)(a), above, and Respondent's cooperation detailed in subparagraph (3) (b) above, Staff agrees to reduce the amount of the penalty from \$1,100.00 to \$550.00.
- d. Payment Plan. Respondent agrees to pay to the Public Utilities Commission the amount of \$550.00 within 10 days after the issuance of a final decision of the Commission approving this Stipulation. PROVIDED, HOWEVER, that if the Respondent does not make the payment as agreed to herein within 30 days of the due date, then (1) Respondent's admissions in subparagraph (3) (a), above, shall be conclusive evidence that the violations occurred and that the fines are therefor justified, and (2) Respondent must pay the full amount of the penalty, \$1,100.00.
- 4. In the event that this Stipulation is modified or not approved in its entirety, either Staff or Respondent, at that

party's option, may withdraw from this Stipulation. In that event, Docket No. 03G-486EC shall be set for hearing.

5. The Staff of the Colorado Public Utilities Commission and Respondent request that the presiding Administrative Law Judge accept this Stipulation in settlement of 28377-CPAN, issue an Order consistent with this Stipulation and its provisions, and close Docket No. 03G-486EC.
