I. <u>STATEMENT</u>

1. By its Application for an Extension of Certificate of Public Convenience and

Necessity PUC Number 53589 (Application), Town & Country Transportation Services, Inc.

(Applicant), seeks to extend operations under its existing Certificate of Public Convenience and

Necessity as more specifically described in the Notice of Application Filed. The Application,

filed on October 16, 2003, commenced this docket.

2. On January 12, 2004, the undersigned Administrative Law Judge (ALJ) issued

Recommended Decision No. R04-0037 (Decision). In that Decision the ALJ inter alia accepted

a stipulation proffered by the parties, approved the amended Application, and closed the docket.

3. On January 13, 2004, Applicant filed a Motion for Entry of Errata to Decision

No. R04-0037 and for Waiver of Response Time (Motion). In that Motion Applicant notes that

the Decision contains an error in the description of the authority sought and granted to Applicant.

4. In Decision No. R04-0037-E, issued on January 14, 2004, the ALJ corrected the error identified by Applicant in the Motion. As granted, therefore, Applicant's authority reads:

Transportation of

passengers and their baggage in taxi service

between all points within an eight mile radius of the intersection of U.S. Highway 287 and Colorado Highway 119 in Longmont, Colorado, and from said points, on the one hand, to all points in the State of Colorado, on the other hand.

5. Issuance of the errata provided the relief sought in the Motion. As a result, the Motion will be denied as moot.

II. ORDER

A. It Is Ordered That:

- 1. The Motion for Entry of Errata to Decision No. R04-0037 and for Waiver of Response Time is denied as moot.
 - 2. This Order is effective immediately.
